**Elected Offices that Must Be Filled:**

***Vice-President for Membership:*** This person will be supported by the part-time administrative assistant we expect to hire. The role will involve contacting MLCRA representatives and others in member communities and supporting them in running annual membership drives. MLCRA will also reach out to communities that are not now members so they will mount membership drives.

***Vice-President for Areas:*** This person will work with MLCRA members in our four areas across Massachusetts to put on at least one Area Meeting there each year. Assistance will also be provided for increasing the communication among the communities in each area.

***Recording Secretary:*** This person will take the minutes at each board meeting and prepare them for distribution to all board members.

***Members-at-Large:*** These people will attend board meetings as voting members and take on projects that are developed by them with the MLCRA president.

**Other Needs:**

The **MLCRA Website** is in need of new leadership because Donald Stevenson is unable to be as active as before in MLCRA work. There must be MLCRA members who have developed and maintained websites. Other skills in electronic communications will also help MLCRA be more effective.

The **MLCRA Legislative Committee** has been led very capably by Angelo Giambusso but his

health is requiring him to take a less active role in that work in the future.

## The MLCRA Annual Meeting May 18, 2015
