



Advocacy and Education

The two bills MLCRA has voted to support are

► An Act Authorizing Common Sense Health Services in Assisted Living Facilities (S 374 and H 650) and

► An Act Relative to Disclosing Continuing Care Retirement Community Entrance Fees. (S417 and H 746).



Advocacy and Education

- In Massachusetts, Assisted living facilities have been certified and regulated for 27 years, as a special combination of residential and personalized support services designed to meet the needs of those who require help with activities of daily living.
- These activities include tasks related to bathing, dressing, grooming, eating, and other similar personal care needs
- ► The Massachusetts Assisted Living Association (Mass-ALA) first introduced a bill six years ago permitting but not mandating assisted living nurses to provide a discrete set of simple, non-invasive treatments. MLCRA supports this bill.




Advocacy and Education

- ► The second bill we are supporting is an Act Relative to Disclosing Continuing Care Retirement Community Entrance Fees. (S417 and H 746).
- Continuing Care Retirements Communities (CCRCs) involve an Entrance fee and some sort of return of that fee when the resident no longer resides in the community.
- ► The return of a portion of this fee, usually refunded to the estate of the resident when he or she passes, or to the resident him/herself should he/she decide to move out, is handled differently, and not always transparently, by the various CCRCs.
- Currently, the CCRC is not required to provide the resident with any document that spells it all out.


